1. The caterer/hotelier is required to bear the amount of Rs. 2,09,128.00 (Rupees Two Lakhs nine thousand one hundred and twenty eight only) towards license of the food court for a period from 14th Nov to 27th November 2016, for the area of outlet – 24sqm through TSTDC to IITF, New Delhi.
2. The caterer/hotelier is required to pay an amount of Rs. 1,37,500.00 towards security deposit(refundable) through TSTDC to IITF.
3. The electricity, water and gas charges are to be borne by the caterer/ hotelier.
4. All the raw materials and consumables for food production including manpower has to be provided by the caterer/hotelier.
5. All the disposables and packing material with the monogram of TSTDC shall be provided by the caterer/hotelier.
6. Accommodation for the staff of caterer/hotelier should be taken care by successful caterer/hotelier.
7. TSTDC will provide supervisory staff for issuing of food tokens and accounting of amount from the sales.
8. The billing machines for printing of tokens for issue of food and accounting of sales shall be provided and operated by TSTDC staff.
9. The revenue sharing will be accounted on daily basis after the closing of the sales for the day.
10. All the taxes as applicable shall be borne by successful caterer/hotelier
11. The successful caterer/hotelier shall provide food to the TSTDC staff, who will be on supervisory and accounting duties.
12. Food shall be provided to inspecting authorities, VIP's on complimentary basis will be shared by the successful caterer/hotelier and TSTDC on the cost price on equal ratio as 50 % each.
